


# How will the "new" Weatec be installed?

A closer look at the hardware and software configuration being used on the Weatec system




## Mobile Devices

Filter and Accountability apps are installed on devices.



## Larger company with many desktop devices

Filter may be configured on a separate hardware device, such as a firewall or proxy server. The accountability app is on all devices.



## Smaller business with only a few desktops

Filter and Accountability apps are installed on devices.



## Weatec Analysis Server

This server takes care of analyzing all internet activity for all the devices connected to the Weatec accountability program. The server logs and scores all suspected noncompliance.

Business Owner is automatically notified of suspected noncompliance.




### Internet Filter

Selection of approved commercial filters to choose from.




### Accountability Program

Tamper proof reporting of all internet activity. The accountability program will not block any activity.



## Weatec Deacon Board and Home Deacon

Intentional and/or repeated noncompliance is forwarded to the deacons.




## Weatec Committee

Random Weatec Members Relation Committee members will review all suspected noncompliance to determine if it is true noncompliance or a false positive. Compliant activity is not reviewed by committee members.



# Features of the “new” Weatec




## Desktop, Laptops, and Tablets Supported

The new Weatec is not being developed for any one specific type of device. To accomplish that goal, the new system focuses more on behaviors and content rather than device types. The Weatec system works with most land line and mobile internet connections.

## Designed For Any Size Business, Small to Large

Business owners have some choices on which one of the Weatec approved filters they want to use. Some filters are better for companies that have only a couple of devices, while other filters can handle tens or hundreds of devices.



## No Wait Time For Weatec Review

Business owners will have the capability and responsibility to configure and control the internet filter portion of their system. This will allow them to make adjustments to their filter without pre-authorization from Weatec. The tamper proof accountability program will always report internet activity to Weatec for review, so if the filter is not configured to comply with the established guidelines, the business owners can expect a contact from Weatec and ultimately a call from his home deacon.


### Accountable to the Brotherhood

## Guidelines


Acceptable and not acceptable uses is based on established and approved guidelines. These guidelines are established on Biblical principles.



The Weatec Board of Deacons and the committees working under them keep the guidelines up to date as new ways to use electronic technology emerge. (Weatec Board of Deacons is appointed by Weaverland Conference)

## Automated Reporting

The Weatec Analysis Server uses a complete list of parameters to determine potential non-compliance versus acceptable use.



## Review

Random Weatec Members Relation Committee members will review all suspected noncompliance to determine if it is true noncompliance or a false positive. Intentional and/or repeated noncompliance is forwarded to the deacons.
